

## ***ELECTION REPORT*** ***April 23, 2016 Election***

**On behalf of the appointed Board of Elections for the City of Milford, I, Eric Norenberg, City Manager, do hereby report the certified results of the April 23, 2016 City of Milford Annual Election to be as follows:**

**With only one contested Council race in the First Ward, a total of 255 persons voted, with Arthur J. Campbell receiving 181 votes and Anne L. Villalobos receiving 74 votes. As a result, Arthur J. Campbell has been declared the winner. Following the Oath of Office, Councilman Elect Campbell's two-year term will commence this date, the 2<sup>nd</sup> day of May 2016.**
